Subject: Alternative Option for the Orange Line Shutdown

Dear Governor Baker:

On behalf of A Better City and its more than 130 members, I am asking you to consider an alternative to the planned 30-day MBTA Orange Line shutdown. We understand the urgency and necessity to move forward with the safety repairs on the MBTA Orange Line as identified by the Federal Transit Administration (FTA). MBTA riders deserve safe, reliable, and affordable transit service, and the municipal leaders, business community, and engaged stakeholders are ready to assist you during the forthcoming disruption from a potential shutdown of the entire Orange Line and parts of the Green Line.

I understand the current MassDOT and MBTA option would move forward with a full shutdown between August 19th through September 19th. Based on concerns from riders, students, school officials, businesses large and small, and our health care and academic institutions, I am proposing an alternative option that prioritizes FTA safety directive actions through a full shutdown for 18 days (August 19th to September 5th) and then weekend shutdowns from September 9th to October 22nd to accomplish the remainder of the work.

Attached is a summary of this alternative that builds off the administration's current plan. This option should allow the MBTA to complete all FTA-mandated safety repairs to the Orange Line this fall, while also meeting the needs of the region and the many impacted riders by resuming vital weekday daytime rapid transit service immediately after Labor Day. Currently, the MBTA is only contracted with one major company for Orange Line bus mitigation service; however, there are a number of companies in the regional marketplace that can assist you with bus service during the additional five weekends after September 19th if you pursue this alternative plan.

We hope that you seriously consider this alternative option. I believe this is the most viable approach to help the MBTA immediately address the FTA's safety concerns on the Orange Line without crippling the economy as we enter the post-Labor Day period. We look forward to your response.

Summary:

The MBTA's newly announced proposal to shutdown the Orange Line 24/7 for 30 days (Option 1) starting August 19th running through September 19th. An alternative Option 2 would retain Option 1's same 24/7 shutdown starting August 19th except that 24/7 shutdowns on weekdays would end as of Labor Day, Monday, September 5th.

Under this alternative Option 2, weekday service on the vital Orange Line would restart on the day after Labor Day. Construction work would then continue over extended shutdowns on weekends only. As compared to Option 1, Option 2 would require only five (5) such additional weekend shutdowns to provide a similar amount of actual work hours. The time lost for actual work due to crew/equipment mobilization and demobilization has been factored into the analysis. Option 1 would provide 764 work hours in total. 792 work hours would be provided in total under Option 2.

Option 1: MBTA's 30-day 24/7 Shutdown

Shutdown begins: August 19th
 Shutdown ends: September 19th

The MBTA's current proposal would provide **764 work hours** in total over the 30-day period. This includes the loss of 2 hours of work at the start of the 30-day period for mobilization onto the tracks and a similar loss of 2 hours of work at the end of the 30-day period for demobilization. The calculations used in this analysis are shown in the attached **Table 1**.

Option 2: Full 18-day Shutdown followed by only 5 Additional Extended Weekend Shutdowns

- Shutdown begins: August 19th
- Shutdown ends: September 5th
- Weekday Service reopens: September 6th
- Weekend shutdowns for seven consecutive weekends—but only five additional weekends as compared to Option 1—starting on Friday September 9th and finish on the weekend ending on October 22nd

The MBTA's current proposal to close the Orange Line 24/7 starting on August 19th would be retained, but 24/7 closures would cease, and this vital transit line would reopen on weekdays starting on Tuesday, September 6th. The initial 24/7 shutdown period would last 18 days and provide 428 work hours in total, with construction activities focused on FTA safety directive work. Orange Line weekday service would remain open with the exception that on the seven (7) consecutive weekends that follow, it would close starting 10PM on Friday nights and reopen at 6AM on Monday mornings. Note: Under Option 1, the OL would be shutdown during first two of these weekends. Therefore, compared to Option 1, Option 2 would require only five (5) additional weekends of shutdown. The Orange Line would be closed 24/7 throughout each of those seven (7) weekends. A total of **792 work hours** is provided. This analysis includes the loss of 2 hours of work at the start of each extended weekend shutdown period for mobilization



onto the tracks and a similar loss of 2 hours of work at the end of each weekend period for demobilization. See **Table 2** for the calculations used in this analysis.

Lastly, it should be noted that a variation of Option 2 could also include closing the Orange Line on weeknights between Mondays and Thursdays during the hours of 10PM and 6AM, which would allow for 4 hours of actual work time (discounting for work time lost due to mobilization/demobilization) each night between Mondays and Thursdays. This would eliminate the need for the last weekend shutdown, only. Given this minor savings in the calendar, it is not recommended that officials pursue this weeknight work shift variation.
